2011 –2012 ENROLLMENT/RE-ENROLLMENT CONTRACT

I. FEES AND PAYMENTS

An enrollment fee, book fee, and a registration fee is required every year for each student. Tuition and fees are charged to cover a student accident insurance policy, the cost of books, class activities and fees (computer, music, library, etc.) yearbook and school activities (athletics, programs, etc.) In consideration of this contract, I agree to pay the required fees specified below:

Please Note: Tuition payments are non-refundable. Students starting school and then withdrawing (or expelled) are obligated to pay the tuition for the balance of the semester from which they withdraw.

II. RULES AND REGULATIONS

I agree to accept and abide by the rules and regulations adopted by Bible Baptist School as outlined in the handbook as well as any new rules and regulations that are made as new situations arise. I understand that the student’s disregard for these rules and regulations may be deemed sufficient cause for dismissal. I understand if my account is more than 30 days late, my child may not attend school until the account is current. Furthermore, I understand that until my account is paid in full to date, no final report card, diploma or transcript of credits will be issued.

III. PAYMENT PLAN OPTIONS

Please check the payment option that you plan to use.

- 1. Tuition paid in full by August 1 to receive a 3% discount.
- 2. One half tuition due August 3, balance due January 6, no interest.
- 3. Ten Month Payment Plan through SMART Financial Services, no interest. A credit check will be done to qualify.
- 4. Twelve Month Payment Plan through SMART Financial Services, no interest. This option is only available to returning students with a Good payment history. Prior approval is required.

IV. CONTRACT VALIDATION

I understand that this contract becomes valid upon the student’s successful completion of the 2010-2011 academic year. New students will be notified of acceptance based on test results and transcripts before the contract is considered valid.

PLEASE READ THE FOLLOWING INFORMATION CAREFULLY BEFORE SIGNING THIS FORM

1. I understand that attending Bible Baptist School is a privilege.
2. I understand that all students currently enrolled must re-apply each year to be considered for enrollment for the next school year.
3. I understand that I am obligated to pay tuition and registration for this academic year of 2011-2012.
4. I understand that I will not be billed for tuition unless it is past due. If an account is more than 30 days past due, my child/children may not return to school until the account is brought current.
5. I understand that if I have a check returned for NSF there will be a \$25 service charge. If two checks are returned, future payments must be made with cash or money orders.
6. I understand that new applicants are considered for admission on the basis of admission tests and/or previous school records. BBS does not discriminate on the basis of race, color, national and ethnic origin.
7. I understand that no final reports, diplomas, transcripts of grades, grade report cards, or test scores will be issued until all bills, library fines, lunch charges, book fees or other incidental charges incurred for my child are paid in full. I understand that these charges are to be paid with cash, money order or cashier's check and that a personal check will not be accepted when transcripts are needed immediately. Also exams may not be taken at the end of the year unless accounts are current. BBS reserves the right to turn over delinquent accounts to a collection firm.
8. I understand that if my child is a kindergarten student, he may only participate in the graduation program if the account is paid in full by the day of graduation.
9. I understand that the enrollment, book, registration, and capital improvement fees are per student and non-refundable.
10. I understand that it is expected that students will learn to discipline themselves spiritually, emotionally, socially and academically.
11. I understand that Bible Baptist School has the best interests of its students at heart: spiritually, emotionally, academically and socially. Discipline is the responsibility of the home, but I understand that the school will act on behalf of the home while the student is in school. I also understand that there are general rules and regulations that all students will be required to comply with, regardless of the sentiment of the individual family.
12. I understand that if my child(ren) (PreK- 5th grade) is not picked up by 3:15 pm, he will be placed in the Bible Baptist Daycare – Extended Care program, and I will be responsible for these charges.
13. I understand that my child (K-12th grade) is to be in uniform every day unless otherwise specifically announced, and he will be sent home to change if necessary.
